## **REQUIRED DOCUMENTS FOR VISA APPLICANTS**

- PASSPORT
- ENGLISH LANGUAGE CERTIFICATE or CERTIFICATE OF NATIONALITY or other documentation proving English language proficiency
- DEGREE CERTIFICATE with final grade (if available)
- Certificate issued by the relevant university attesting the exams taken (TRANSCRIPT) with dates and grades, along with an official English translation or DIPLOMA SUPPLEMENT, if applicable
- ADDITIONAL DOCUMENTATION (certification of qualifications and courses other than the degree, syllabus, Curriculum Vitae, motivation or recommendation letters, etc.)

**Note:** It is recommended to include the following optional documents:

- CIMEA Verification Statement (obtainable at this link: <a href="https://www.cimea.it/pagina-attestati-di-comparabilita-e-verifica-dei-titoli">https://www.cimea.it/pagina-attestati-di-comparabilita-e-verifica-dei-titoli</a>)
- CIMEA Comparability Statement (obtainable at this link: <a href="https://www.cimea.it/pagina-attestati-di-comparabilita-e-verifica-dei-titoli">https://www.cimea.it/pagina-attestati-di-comparabilita-e-verifica-dei-titoli</a>) for candidates holding qualifications issued by countries that are not signatories to the Lisbon Convention\*. Please note that the processing time for the CIMEA Verification and/or Comparability Statement is 60 working days. It is therefore advisable to submit the request as soon as possible.
- Declaration of Correspondence, downloadable from the ARDI platform
  (<a href="https://ardi.cimea.it/en">https://ardi.cimea.it/en</a>), for candidates holding qualifications issued by countries that are not signatories to the Lisbon Convention\*.

Presenting these documents during the registration phase IS NOT MANDATORY, **but** possessing them may facilitate the subsequent visa issuance process, as admitted candidates will need to upload these documents to the Universitaly platform for visa application and enrollment purposes.
